1. The Dolphin Motor Club will organise a 12 Car navigation rally, on 13th November 2009, starting & finishing at the Halfway Inn, 407 ¼ 684 ½. Permit No:- 55060
2. The event is open to all members of the organising club, Oxford Motor Club, OUMDC, Basingstoke Motor Club, Hart Motor Club & Wessex Motor Club.
3. All competitors must produce a valid club card.
4. The program of the event will be.

Scrutineering and signing on will start at 7.15 PM. All competitors and marshals must be signed on by 7.50 PM.

A meeting of all drivers and navigators will take place at 7.50 PM in the car park (weather permitting).

#### **ALL MUST ATTEND.**

5. Cars will start at one minute intervals; first car will start at 8.01 PM. Total mileage will be approximately 55 miles on maps 174 edition D1.
6. The event will consist of three classes as follows:
  - I. Experts – any crew whose navigator has won a 12-car rally or an award on a higher status road rally.
  - II. Novices – any crew (excluding Beginners) whose navigator has not won a 12-car, or competed on a higher status road rally.
  - III. Beginners – any crew whose navigator has competed in no more that 3 previous 12-cars, and has not finished in the top 3 thereof.
7. The entry list opens on publication of this notification and closes at 7.45 PM. on the 13th November 2009.

10. Insurance is by the Lockton Motor Sports Club Scheme:

The Club have applied to Lockton for a Blanket Cover Note under the above scheme. This will provide Competitors who need to use the Scheme with Third Party Cover necessary to meet RTA requirements on the Road Sections of the Event.

The basic rate for the Event (before any loadings) will be £15.90

New applicants wishing to use the Scheme must be able to comply with all points of the following Declaration:-

- Over 21 and Held a Full Licence for at least 6 months
- Not more than 1 fault accident in last 3 years
- No more than a maximum of 6 speeding points on licence
- No physical or mental disabilities
- No other material facts

**If you are able to comply** with all points above all you will need to do is simply sign on the Lockton signing on form, for Insurance, at signing on for the event. - **No Letter of Acceptance will be issued.**

**If you are unable to comply** with any of above points you will need to complete a Declaration Form. Either contact the Organiser for one or go direct to Lockton several days prior to the Event to allow sufficient time for it to be returned or faxed to the Insurers for a letter of Acceptance to be issued.

11. Provisional results will be published as soon after the end of the event as possible. Results will be made final as soon as possible after the provisional results are published and printed in the next Dolphin M C newsletter.
