

- 1. The Dolphin Motor Club will organise a 12 Car navigation rally, on Friday 18<sup>th</sup> January 2013, starting and finishing at 'The White Hart' PH at Hampstead Norreys, Grid Ref 174/531763½. Permit No:- 73282.
- 2. The event is open to all members of the organising club, Oxford Motor Club, Basingstoke Motor Club, Devizes MC, Farnborough District Motor Club, Guildford MC, Hants & Berks MC, Thame MC, OUMF, Windsor Car Club, Witney MC & Wessex Motor Club.
- 3. All competitors must produce a valid club card.
- 4. The program of the event will be.

Scrutineering and signing on will start at 7.00 PM. All competitors and marshals must be signed on by 7.50 PM.

A meeting of all drivers and navigators will take place at 7.50 PM in the car park ALL MUST ATTEND.

- 5. Cars will start at one minute intervals; first car will start at 8.01 PM. Total mileage will be approximately 59 miles on map 174 edition D2.
- 6. The event will consist of three classes as follows:

Experts – any crew whose navigator has won 3 or more12-car rallies or an award on a higher status road rally.

Novices – any crew (excluding Beginners) whose navigator has not won more than 3, 12-cars, or an award on a higher status road rally.

Beginners – any crew whose navigator has competed in no more that 9 previous 12-cars, and has not finished in the top 3 of more than 3 events.

7. Awards will be presented as follows:

1st Overall 2 awards. Subject to at least 7 starters. (Awards to be presented at Dolphin Awards Night)

14. Insurance is by the REIS Motor Sports Club Scheme:

The Club have applied to REIS for a Blanket Cover Note under the above scheme. The basic rate for the Event (before any loadings) will be £15.

Competitors must have Insurance in place which provides Third Party Liability cover that complies with the Road Traffic Act. This can be an extension to the existing motor-policy for the car or purchased via the event organisers. If a competitor uses an extension to an existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor. If a competitor wishes to purchase cover via the organisers then they can do so prior to the event providing they comply with the following:

Age 19 Years or over Has held a full licence for a minimum of 6 months Has no more than 6 points on their Licence Has no more than 1 fault claim in the last 3 years

Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25. Any competitor, who falls outside these parameters, may
